Anbuchezian, Member Secretary and Principal, Annapoorana Engineering College presented the agenda, item by item, as follows for consideration discussion and finalization.

Agenda 11.1: Review and approval of the previous meeting minutes.

Resolution 11.1: Based on the previous governing council meeting held on 25.05.2019 the action was taken and report of action taken was discussed by the governing council members.

Agenda 11.2:To approve the new vision and mission of the institute

Resolution 11.2: The institution now applied for NAAC accreditation. The earlier Vision and Mission statements needs to be revised for accreditation point of view. Accordingly, the institute prepared new Vision and Mission Statements for the institute after consulting all the stake holders. The proposed Vision and Mission statements were presented in the meeting. Some of the members suggested some minor corrections, with these minor corrections the new Vision and Mission were approved by the Board.

Agenda 11.3: Value added programs/Certificate Courses/VET /Bridge Courses

Resolution 11.3: Principal discusses about the addition of new value added courses to impart skill to the students to make the existing programmes more employable. The Governing council resolved and approved it.

Agenda 11.4: Infrastructural facilities created and proposed

Resolution 11.4: The principal informed about enhancements that will be done in the College building infrastructure. Principal submitted the proposal for New Infrastructure Requirements, such as Purchasing of Zoom app for handling online class, Green initiatives for planting trees/plants, planting Miyawaki Garden, upgradation of Sports grounds, Construction of Indoor Stadium, Construction of Basket ball Court and also maintaining the CAMU software.

Agenda 11.5 Training and Placement activities

Resolution 11.5: The Governing Body recommended that the College shall attract more reputed companies and organizations so as to get placement to more students. The Governing Body appreciated the efforts made by the College in signing MOUs with the various companies in educational training, internship, industrial visit, inplant training, placement and research.

Agenda 11.6: NAAC Accreditation

Resolution 11.6: As per schedule, the NAAC visit was slated in 2nd and 3rd April 2020. But due to Covid'19 pandemic, the NAAC inspection was rescheduled. The Members suggested that the Principal and the faculty members to be ready for the Peer team visit at any possible time. Agenda 11.7: Anna University Result Analysis

Resolution 11.7: The Principal presented the result analysis and various academic activities conducted by the departments. He informed that the results of the students are found satisfactory and also stressed on the need to concentrate more on ICT enabled Learning Management for improving student learning and achieve academic excellence. The Governing body suggested identifying weak students and conducting remedial courses / bridge courses especially in Mathematics and English.
