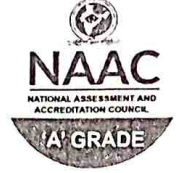

She will signify the acceptance of this order of appointment in writing by returning **the duplicate copy** of this duly signed under the said terms and conditions.

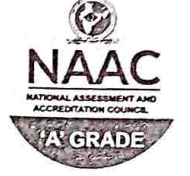
